

The Henkel Spend \$30 Get \$10 Offer Terms and Conditions

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY ACCESSING OR PARTICIPATING IN THE HENKEL SPEND \$30 GET \$10 OFFER, YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND ALL TERMS INCORPORATED BY REFERENCE.

Offer Timing: The Henkel Spend \$30 Get \$10 Offer (the “**Offer**”) begins on February 7, 2021 at 12:00 a.m. Eastern Time (“**ET**”) and ends February 27, 2021 at 11:59 p.m. ET (the “**Purchase Period**”). All purchases must be made within the Purchase Period. All receipts from the Purchase Period must be submitted by March 7, 2021 at 11:59 p.m. ET.

Eligibility: The Offer is open only to legal residents of the 50 United States and the District of Columbia who are eighteen (18) years of age or older as of date of Offer redemption.
