1. AGREEMENT TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS

By submitting your receipts and a Reward request in connection with this Program (defined below in Section 3), you are signifying your agreement that you have read and agree to be legally bound by these Terms and Conditions (the "**Terms and Conditions**").

2. SPONSOR

Purchases must be made between October 28, 2019 at 12:00:00 a.m. Pacific Time and November 24, 2019 at 11:59:59 p.m. Pacific Time (the "**Purchase Period**"). Submissions (defined below) must be made in accordance with Section 5(i) or (II), as applicable. Participation in the Program is only open to legal residents of Canada, 18 years of age or older (at the time of participation), with a valid Canadian mailing address (each such resident, a "**Participant**", or "**you**"). The Sponsor, other Program Parties, Costco Wholesale Canada Ltd. ("**Costco Wholesale**"), and each of their respective officers, directors, agents, representatives, successors, assigns, parent corporations, subsidiaries, affiliates and distributors (collectively, the "**Released Parties**") are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete, or illegible Submissions (as defined below, and all of which are void).

4. THE PROGRAM

Sponsor is offering eligible Participants the opportunity to receive a \$25 Costco Shop eCard (the “**Reward**”) when they purchase Participating Products (as set forth on Exhibit A attached hereto, the “**Participating Products**”) totaling \$100 (after discounts and before taxes) or more from Costco Wholesale at any Costco Wholesale warehouse located in Canada, or on Costco.ca, during the Purchase Period. Availability of Participating Products is subject to inventory and may vary by location. Purchases may be made over multiple transactions during the Purchase Period and aggregated for purposes of reaching the qualifying total purchase amount (explained in Section HOW TO PARTICIPATE below). **Limit of two (2) Rewards per Costco member.**

5. HOW TO PARTICIPATE

Participants may participate in the Program by completing all of the following steps: (a) purchasing \$100 (after discounts and before taxes) or more of Participating Products from Costco Wholesale or on Costco.ca; (b) ensuring that the applicable sales receipt(s) identify the date(s) of purchase and that such date(s) is/are within the Purchase Period (purchases may be made over multiple transactions during the Purchase Period); and (c) submitting a Reward request by either of the following methods (such submission, a “**Submission**”):

Mail-in Submissions must be legibly printed to be eligible.**

If a Submission is incomplete or fails to meet any of the Terms and Conditions, no Reward will be issued. Participants should keep copies of all Reward Submission documents; all Submissions become the property of Sponsor and will not be returned.

6. PROCESSING OF SUBMISSIONS

No substitutions are permitted. Rewards will only be sent to the Participant whose verifiable full name and valid email address appears on the registration form associated with the Submission in question. You are responsible for any damage/loss due to use of a Reward. By participating in the Program, you agree to release, discharge, indemnify and hold harmless the Released Parties from any liability or damages which may arise out of participation in the Program or out of the acceptance, use, misuse or possession of any Reward.

9. GENERAL CONDITIONS
