**Offer Terms and Conditions**

**PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY PARTICIPATING IN THE PAMPERS \$10 DIGITAL PREPAID CARD OFFER, YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND ALL TERMS INCORPORATED BY REFERENCE.**

**Offer Timing:** The Pampers \$10 Digital Prepaid Card Offer (the “**Offer**”) begins on January 18, 2021 at 12:00 AM Eastern Time (“**ET**”) and ends February 1, 2021 at 11:59 PM ET (the “**Offer Period**”). Submissions must be received online by 11:59 PM ET February 15, 2021.

**Eligibility:** The Offer is open only to legal residents of Canada who are nineteen (19) years of age or older. Employees of Procter & Gamble Inc. (the “**Sponsor**”), its parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate in the Offer.
